## PROFILE OF MR PRADEEP KUMAR MISRA

Born on 1st July 1953 in Varanasi, Mr Pradeep Kumar Misra is an alumni of St Xavier's from the batch of 1969. After a Post Graduate degree with high honors in Economics from the renowned Delhi School of Economics, he taught Economics in the Shri Ram College of Commerce, Delhi University, before joining the IAS.

After joining the IAS in 1976, he worked in the State of Uttar Pradesh, his allotted cadre, in the field and District level and was District Magistrate Etah District. He worked for about 3–1/2 years in the late 1980s as Director, Tourism and Managing Director, U.P. Tourism Development Corporation before moving to the Centre in late 1989 as Director in the Ministry of Surface Transport, where he held important positions in the Ports and Shipping sectors.

Thereafter, he worked in the State of U.P. as Registrar of Cooperative Societies, Sales Tax Commissioner and Secretary Finance, Government of U.P. In addition, he has worked at the State level in diverse fields which include Industrial Finance, Health & Education.

From 1998 to 2003, he worked as Joint Secretary in the Ministry of Defence, Government of India, where he acquired expertise on national security issues & geopolitics. He was responsible for acquisitions of equipment for the Air Force and Navy and acquired a deep insight into these processes.

In 2007, Mr. Misra was appointed as Establishment Officer & Additional Secretary, Government of India and Secretary of the Appointments Committee of the Cabinet, which considers appointments to the top jobs in the Central Government, Public Sector Undertakings, Banks, Financial Institutions and Autonomous Organizations of the Central Government. In this capacity, his role was to advise the Appointments Committee of the Cabinet on these key appointments.

From 1st September 2010 to 15th January 2012, Mr. Misra was Secretary, Steel, Government of India. As a helmsman of the Steel Ministry in India, he was responsible for nurturing its growth and dynamism in an era of high growth in the sector. In this capacity, he was actively involved in shaping the policies which will ensure the ambitious capacity expansion plans of the Indian Steel companies both in the public and private sector. He helped the steel industry to acquire iron ore and coal mines in India and abroad.

Mr. Misra was Secretary, Department of Personnel & Training, Ministry of Personnel, Public Grievances and Pensions from 16<sup>th</sup> January 2012 till his superannuation on 31<sup>st</sup> July 2013 In this capacity he was responsible for the personnel and training policies and anti-corruption activities of the Central Govt.

Mr. Misra was a keen athlete in School & College & represented Delhi state in the Nationals in 1971. He was an avid mountaineer & took part in three major expeditions including to 'Trishul' in the Himalayas. He was invited to the Institute of Directors as a distinguished fellow & has also earned many other awards & accolades in his long & distinguish career. St Stephens College from where he graduated also honored him in 2013 as a Distinguished Stephenian.
