

**NOTES**

- 1 The Company's Integrated Steel & DI Pipe Plant in the State of Jharkhand, India, is under construction & erection. A part of plant facility has commenced production and accordingly the proportionate expenditure related to the project has been accounted as 'Project Development Expenditure' pending capitalization under 'Capital work-in-Progress'
- 2 The Company has, during the quarter, capitalized part of the plant facility (Blast Furnace 2). Accordingly the Pre-Operative Expenses incurred upto the date of capitalization have been allocated to the cost of the facility on a proportionate basis.
- 3 Pursuant to the Companies Act, 2013 ('the Act') becoming effective from 1st April 2014, the Company has recomputed the depreciation based on the useful life of the assets as prescribed in Schedule II of the Act. The depreciation charged for the quarter ended 30th June 2014 is lower by Rs 745.58 lacs. Further, in accordance with the transitional provisions of Schedule II, the Company has adjusted Rs 519.03 lacs in the opening balance of retained earnings for those assets where the remaining useful life is Nil as on 1st April 2014.
- 4 Considering the nature of the Company's business and operations, there are no separate reportable segments (business and/ or geographical) in accordance with the requirements of Accounting Standard 17 'Segment Reporting', issued by ICAI.
- 5 Previous quarters / year figures have been reclassified wherever appropriate to confirm to current year's presentation.
- 6 The above audited results were reviewed by the Audit Committee and thereafter approved by the Board of Directors at its meeting held on 13th August, 2014.
