Prez of Bharat's G20 invite draws sharp reactions from JMM, Cong

Move Brought Disrepute To Country: INDIA

Ranchi: Jharkhand Mukti Morcha (JMM), a kev member of the INDIA alliance, lashed out at BJP and its government at the Centre after visuals of President Droupadi Murmu's invite, with 'President of Bharat' inscription, sparked a political row across the country on Tuesday.

JMM, which leads the ruling coalition government along with Congress and RJD in the state, said the incident was an ominous sign for the country and said the Narendra Modi-led government had embarrassed the country on the world stage. "They embarrassed the country on the world stage, the G20 summit. At best, the invitation could have been extended in Hindi, which is our national language. This is a matter of grave

concern, and the people of our country must take note of it," JMM spokesperson Su-

priyo Bhattacharya said. On behalf of his party, Bhattacharya questioned the Centre's silence on the agenda of the Parliament's special session that has been convened later this month. "We fear that the Constitution will be murdered in the special session," he claimed.

The Congress leaders in Jharkhand claimed that the move had brought disrepute to the country. "BJP and its

government at the Center is increasingly getting anxious of the growing strength and popularity of the INDIA alliance and resorting to such deeds. It also shows that the Rashtrapati Bhavan is now completely under the Prime Minister's control. Such tricks are being played out to divert the attention of the countrymen on the large-scale corruption under the Narendra Modi-led government's watch, which have begun tumbling out of the cloment is near," state Congress president Rajesh Thakur told

Meanwhile, Ajsu-P, an ally of BJP in the NDA, stepped back from the brewing controversy. "The matter has been circulating on social media outlets. We do not have any information yet. So we cannot comment immediately," party spokesperson Devsharan Bhagat to \bar{ld} **TOI**.

The BJP top brass in Jharkhand also ducked questions on the matter. Aditya Sahu, a Rajya Sabha MP and general secretary of the party's state unit, said, "I just returned from Dumri after overseeing the by-elections and have not seen the letter

However, BJP insiders claimed that the move was deliberate. "Last year, on the 75th year of Independence. the PM had said that symbols of our colonial past would be taken down gradually. India is a name given by the British." a veteran BJP office bearer told TOI.

Isolate DMK, Babadham priests' group tells state political parties

Dumka/Ranchi: The priests of the Babadham in Deoghar on Tuesday expressed their anguish over the controversial remark made by Tamil Nadu minister Udhavanidhi Stalin, against the Sanatan Dharma recently.

While speaking at a conclave organised by the Tamil Nadu Progressive Writers' Forum on Saturday last week, Udhayanidhi, the son of Tamil Nadu chief minister M K Stalin, reportedly likened the Sanatan Dharma to dengue and malaria and stressed that it should not be merely opposed but eradicated. His statement triggered a nationwide outrage.
Alleging that Stalin ju-

nior's remarks had hurt the sentiments of scores of the Hindu community, the Babadham priests demanded that all political parties from Jharkhand, who are part of the INDIA bloc, should distance themselves from Stalin's party, DMK.

Opposition BJP, too, lashed out at chief minister Hemant Soren, who is also the executive president of the ruling Jharkhand Mukti Morcha (JMM), for remaining silent over the matter



never involved in political discourses until the attack by the TN minister

and sought his party's and his views on the issue.

Earlier on Monday, West Bengal chief minister Mamata Banerjee said requested people of Tamil Nadu to respect every religion and its sentiments. "India is a secular and democratic country. I respect Sanatan Dharma. We go to temples, mosques and churches. We should not be involved in any matter which may hurt anyone." Her Jharkhand counterpart, Soren, and his party are vet to air their views. which upset the priests of Babadham.

Speaking to TOI, the general secretary of the Panda Dharmarakshini (priests' body at Deoghar temple), Kartik Nath Thakur, said, "Given the way the DMK leader spewed venom against the Sanatan Dharma that has around 80% followers in country, it is high time for the disciples to raise their voices against the south Indian minister, in particular, and all political partners of DMK in general." Notably, the Deoghar priests' body does not have any political affiliation and never indulged in political mudslinging in the past, Thakur said.

"It seems that the organisers of the event where the minister spoke had purposefully planned the attacks on Sanatan Dharma, Hence, they should also be booked for hurting the religious sentiments of the majority of the people of the country," Thakur demanded, stressing that they would chalk out their next course of action against the statement soon. Meanwhile, state BJP president Rahulal Marandi demanded that Soren should clear his stand on the issue.

Bihar woman booked under **NDPS Act**

Daltonganj: Town police arrested a woman identified as Puja Kuar of Baingahi village under Nabi Nagar police station in Auranga bad district of Bihar on Tuesday with 3.42 kg narcotic substance that looked like marijuana, in Daltonganj town. The consignment was in two packets weighing 1.830 grams and 1.590 grams respectively, police said. Police have also seized her cell phone. A press note issued by town police said that the woman has been booked under relevant sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

Officer in-charge of town police station Abhay Kumar Sinha said, "Cops had questioned her regarding the recovered substance. She was caught at NH 75 planning to sell the consignment." This is the first time here that a woman was caught with contraband substance. Investigation is on and police is yet to find out how the woman arrived here with the consignment, whether she has any criminal links or a local source and to whom she was going to sell the consignment.

e, however, highlighted the high female voter Lturnout and said, "Encouragingly, the female turnout was 72.77% compared to their male counterparts which stood at 57%. The low turnout of male voters could be because they may have migrated to other places for work given the poor monsoon." Lakra stressed that the entire voting process remained peaceful without any untoward incidents or major EVM malfunctioning. "Everything went according to plan and there are no reports of untoward incidents or issues of recasting of votes and so on," he added.

The counting will take place on September 8. The seat fell vacant after the death of then education minister and JMM MLA, Jagarnath Mahto, early this year. The JMM-Congress-RJD combine has fielded Jagarnath's widow Bebi Devi. who was already inducted in the state cabinet a month ago with a view to retain the seat. Ranchi: The Lok Sabha's Committee on Privileges has asked former Deoghar deputy commissioner Manjunath Bhajantri and Jharkhand chief secretary Sukhdev Singh to appear before it in person on September 21 and present their oral evidence on a notice of breach of privilege moved by Godda's BJP MP Nishikant Dubey in September 2022. An office memorandum issued by the Lok Sabha Secretariat's privileges and ethics branch on Tuesday, a copy of which is with the TOI, asked the Union ministry of Personnel, Public Grievances and Pensions to ensure that both the civil servants appear before the committee on the scheduled date

and time. Dubey, a three-term MP from Godda parliamentary constituency in Jharkhand, had filed four breach of privilege notices against Bhajantri, a graduate engineer from IIT Mumbai and a 2011 batch IAS officer, between 2021 and 2022 accusing the latter of misusing his official position. Bhajantri, now posted as the

deputy commissioner of East Singhbhum district, had reportedly sent a written response to the committee in June this year which was in violation of the Lok Sabha procedures. Bhajantri and Singh's offices did not respond to TOI's calls when contacted. The Lok Sabha's standing committee on privileges is currently headed by Sunil Kumar Singh, the incumbent BJP MP from Chatra Parliamentary constitu-

ency in Jharkhand. "The officer had, out of personal vendetta, implicated me and my family members, including my wife, children and mother in false cases. He insulted me, a people's representative on several occasions. My constituency is made up of three districts, and I generally do not interact with their DCs and SPs," Dubey said.

The face-off between Dubey and Bhajantri began in April 2021 when the officer wrote to the Election Commission accusing the former of violating the model code of conduct during the Madhupur by elections. Dubey accused the officer of working at the behest of the ruling Jharkhand Mukti Morcha.

Dubey then accused Bha-

jantri, then Deoghar DC, of filing 37 FIRs against him and his family members ac cusing them of inking forged land deals. The MP also accused Bhajantri of curtailing his security. The fight betwe en the duo peaked in August 2022 when Dubey was booked along with eight others for allegedly obtaining clearance by force for a flight to take off from Deoghar airport on the evening of August 31 despite the airport not having night take off or landing facilities. The duo made sharp exchanges on X (then known as Twitter) and Dubev lodged an FIR against Bhajantri in New Delhi.

Speaker asks police to take action on Dhanbad woman's complaint

Ranchi: State assembly speaker Rabindra Nath Mahto has instructed the police to look into the complaint lodged by a Dhanbad woman accusing the officer-in-charge (OC) of the Chirkunda police station in Dhanbad of harassing her family members with extortion demands. In a tweet, the speaker attached the letter of the complainant and tagged the Jharkhand Police and the Chief Minister's Office with the instruction to take suitable action and inform him of the action taken report.

The complainant, Uma Agrawal, has alleged that the Chirkunda OC has been demanding money from her family, which is in the food products trade. She alleged that on June 16, the OC, along with others, entered her home and misbehaved with her and her family members. She said the OC took away coarse spice samples and handed them over to the drug inspector after five days. While raising suspicions about the OC tampering with the samples, she said the drug inspector has filed a case against her family.

Forest dept to resurrect vulture breeding project at Muta

Ranchi: The state department of forests, environment and climate change has resurrected its efforts to make operational a vulture conservation project on the outskirts of Ranchi which has been dragging its feet for more than a decade. The move comes at a time when the 'The Status of India's Birds Report 2023', released on August 25 this year, has marked the white-rumped vulture and Indian vulture as vulnerable and in the "highest on the priority list in need of conservation" in Jharkhand.

Department authorities have pitched in the idea of joining hands with the Bombay

Natural History Society (BNHS), a Mumbai-based charitable organisation associated with biodiversity research for operationalising the conservation centre at Muta village in Ormanjhi, nearly 27 km northeast of Ranchi. The department tried run-

ning the facility on its own by bringing in a few vultures from Pinjore in Haryana but failed. Interestingly, the proposed centre at Muta village was a crocodile breeding site until March 25, 2018, After crocodile breeding at the site failed, the centre has been

languishing for nearly half a Talking to TOI on Tues-

day, chief conservator of forests (wildlife) S R Natesha said. "We obtained clearances from the Central Zoo Authority for our proposed vulture conservation centre at Muta a few years ago. However, there have been some administrative hurdles which have led to delays in obtaining clearances from the state government. A fresh proposal has been moved and the government's queries have been answered. We are hopeful of making it operational very soon.

While Natesha did not give a timeline, sources in the department said efforts were

underway to ink an MoU with the BNHS by September-end. "Thereafter, the centre could be made operational within the ongoing financial year," a senior officialtold TOI. The provisions of the MoU entail that the BNHS would provide technical expertise while the state government would fund the project. As per BNHS estimates, there are nine species of vultures in India and their cumulative population was 40,000 earlier this year. Jharkhand, home to two species out of the total nine, has anywhere between 350 to 500 in its wild. Hazaribagh, Koderma and Saranda are home to a bulk of the state's vulture population
