- We conduct regular risk assessments to identify, evaluate, and prioritize potential threats which are vulnerabilities to our business processes and information assets. We make comprehensive risk treatment plans to minimize the impact of disruptive incidents in our operations.
- We conduct Business Impact Analyses to understand the criticality of our business processes. By prioritizing
 these processes, we focus on resources and ensuring the continuity of our most essential operations during
 and after disruptive events.
- ESL employees, contractors, and stakeholders will receive regular training and awareness programs. These
 initiatives empower them to understand their roles and responsibilities during disruptive incidents. Through
 regular drills and exercises, we continually enhance our response capabilities and evaluate the effectiveness
 of our BCMS.
- We monitor, assess learn from real incidents and simulation exercises and implement necessary improvements promptly.
- The top management of ESL Steel Limited is responsible for the effective implementation, maintenance, and continual improvement of the BCMS. All employees, contractors, and stakeholders are expected to support and comply with this policy and actively contribute to the success of our business continuity efforts.
- This BCMS policy will be reviewed annually and revised as necessary to ensure its ongoing relevance, effectiveness, and alignment with the organization's objectives and the evolving threat landscape.
